Minutes of June 10, 2015

The Board of Public Works and Safety met in Regular Session Wednesday, June 10th, 2015, at 9:00 AM in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

The meeting was called to order by Mayor Franklin.

FIRE CHIEF: Mark Strong, present.



Further discussion followed. Mayor Franklin made a motion to approve the reviewed areas. Ron Miller seconded the motion. Motion carried 2-0.


BOARD MEMBER COMMENTS: None
