These cars needed to be plated or covered. The property owner is opposing these fees. The fees total \$1500. The property owner stated to Dave that he would regulate the cars and gets them plated. Dave made a motion to suspend the \$1500 in fines from the city. Jim Brugh suggested that Dave put this in writing to make it binding. Dave withdrew his motion and is going to have the agreement put in writing and include the property owner's name.

Moved by Mayor Dave Kitchell, **Seconded by** Carl McPherson. Motion passed unanimously.


REPORTS:


