BCA Environmental Consultants has been chosen from the 3 proposals. This is to manage the \$600,000 EPA Grant that they are sharing with Eel Township and Fulton County. Mercedes stated that BCA had the best communication skills and that is why they ended up with the most points on the evaluation forms. Mayor Kitchell stated that BCA is Bruce Carter & Associates who they have worked with before.

Motion passed unanimously.

Mercedes Brugh stated that this is a form for finishing up the bike lanes inspection. Mercedes stated that this job came in \$5,869.53 under the expected cost. Stacy stated that this is accepting that they agree it is complete.

Mayor Kitchell stated that he has had compliments on the alternate bike route signs. Tony Shanks stated that they are going to look at Eel River Ave (Bankers Row) in regards to where those lanes should lead, to First Street or continue over the bridge.

Johnny also mentioned that the city has regularly mowed this lawn and they have had property clean ups in the past there as well.

Follow up inspection was on 7-31-2017. Violation was not corrected.


