#### OLD BUSINESS:

- Application for Curb Cut – Taken under advisement on 2/1/19 Tony Shanks
  - 1414 North Street – Tomas Cervantes-Tonnes  
 Mayor shared that this is just for a curb cut for sewer repair.  
**Motion:** to approve the request for 1414 North Street, **Action:** Approve,  
**Moved by** Mayor Kitchell, **Seconded by** Mercedes Brugh.  
 Motion passed unanimously.

#### NEW BUSINESS:

- Police Department Rob Smith
  - Request for Surplus Property – Polygraph equipment  
 Chief Smith was present to speak to his request. In 2016, the Police Department purchased polygraph equipment and sent an officer for training to operate it. That equipment has not been used since 2016 and the trained officer is no longer with LPD. This officer is now with the Cass County Sheriff's Department and they indicated that the County may be interested in purchasing it.  
**Motion:** to deem the polygraph equipment surplus property, **Action:** Approve, **Moved by** Mayor Kitchell, **Seconded by** Mercedes Brugh.  
 Motion passed unanimously.
  - Monthly report – January 2019  
 Rob Smith shared that the drug taskforce had a large arrest this week, resulting in the removal of drugs and weapons from the community. The patrol crew are also logging lots of miles and calls for service. There were 116 arrests for the month of January. The arrests range from theft, driving with no license, marijuana, and various other infractions.  
**Motion:** to approve the monthly report as presented, **Action:** Approve, **Moved by** Mayor Kitchell, **Seconded by** Mercedes Brugh.  
 Motion passed unanimously.
- Building Commissioner Deb Beattie
  - Condemnation Hearings
    - 531 15<sup>th</sup> Street
 Deb Beattie presented the status of the property at 531 15<sup>th</sup> Street. The owner, Christopher Roberts was present to speak to this property and the next one. He plans to complete the work by the first of May. Deb Beattie brought these properties forward to the Board so she could get a firm plan of action for the properties. The building permit was issued last April, but no work has been done.

The current building permit will expire this April. The house is not occupied. The owner plans to rehab and sell the property. The Mayor asked several questions regarding the delays and the plans for improvement. The Mayor would like to bring this property back for a status hearing on May 1<sup>st</sup>, 2019. Deb recommends that the property be condemned until the work is finished.

**Motion:** to condemn this property today and bring the property back for a status hearing at the May 1st meeting, **Action:** Approve, **Moved by** Mayor Kitchell, **Seconded by** Mercedes Brugh. Motion passed unanimously.

- 1505 High Street

Mr. Roberts owns this property as well. Deb reported the status of this property that is much like the previous property discussed. She would like to get a firm plan of action on this house as well. Deb would like to see a new roof and the soffit and fascia replaced. Deb feels the garage needs a new roof, if not demolished due to its condition of severe disrepair. Deb's recommendation is to condemn the property. This house is not occupied. The owner projects to have this one completed by the first of June of this year.

**Motion:** condemn today and bring the property back to the Board for a status hearing at June 5th meeting, **Action:** Approve, **Moved by** Mayor Kitchell, **Seconded by** Mercedes Brugh. Motion passed unanimously.

Deb Beattie explained that the system picked up the February permits so she has altered the YTD figures to match January.

The first inspection was 1/4/19, door hanger was left and initial letter mailed, a follow-up inspection on 1/11/19 found the violation was not resolved. A certified letter was sent and was not signed for. There has been no contact made with the occupant or the property owner. Johnny was not sure if anyone lives in this house. He reported that some of the debris in the yard has been moved to the porch. Johnny recommends we clean-up the property.


The Mayor inquired about 2010 Smead Street and 16<sup>th</sup> and Broadway – Johnny has sent a letter to both property owners.


