

## **Minutes April 5, 2006**

### **Board of Public Works and Safety**

The Board of Public Works and Safety met for a regular meeting, Wednesday, April 5, 2006, at 5:00 p.m., in the City Chambers, 3<sup>rd</sup> floor, City Building, Logansport, Indiana.

Silent **Roll Call** was taken. Those present were Mayor Fincher, Deputy Mayor Klinck, & Joe Casalini. City Attorney Burns was also present.

Others present: Building Commissioner Hostetler, Fire Chief McMinn, Cemetery Sexton Mike Nicholl, and Code Enforcer Officer Hileman.

**Minutes** from March 29, 2006, accepted as presented on a vote of 3-0.

**Claims** of **\$225,266.83** were approved 3-0.

#### **Old Business:**

After stating problems with health and family illness Mike Rehiling was given a 1 week extension on cleaning up his property located at 717Bringhurst. Mayor Fincher stated that it is the last opportunity.

#### **New Business:**

- ❖ Code Enforcer Officer Hileman presented her weekly report. Recommendation to the Logansport Board of Public Works and Safety for cleanup action was approved on a vote of 3-0. The action is against Jeff Murray, 1826 Michigan Ave; and Brian Bransteter, 521 Bartlett Street. The Logansport Street Department will do the cleanup; the property owners are ordered to pay \$250.00 per hour for cleanup, \$50.00 administration fee and a \$50.00 fine. This report was accepted on a vote of 3-0.
- ❖ Building Commissioner Hostetler presented his weekly report. His department has collected \$214.00 in various fees during the past week. Certificate of Occupancy was issued to: 112 Burlington Ave, Suenos; 1317 North Street, Judy Clark; and 715 Plum Street, Richard Enyeart. Order to Appear report is continued to gather more information as needed for notification. Condemnation was lifted from properties located at 1317 North Street and 715 Plum Street. This report was accepted on a vote of 3-0.
- ❖ Rob McMinn, 35 W. Columbia Street, was granted permission to hold a Block Party for the Cross-wind UMC on June 10, 2006, from 5:00 to 9:00 p.m. The event area will take place on 4<sup>th</sup> Street between the streets of Market and Melbourne. The event is free and open to the public. There will be games, food, and live music.

- ❖ Rev. Doug Mankell, Calvary Presbyterian Church, was granted permission to use city streets for the Annual Race for Grace 5K Race. The event will take place Saturday, June 24, 2006 from 7:00 to 10:00 a.m. Stan Forker of REACT will manage traffic control. Most of the race will be run on Spear Street. A route map was presented. Insurance responsibility has been filed with the Mayor's Office.

**Board Member Comments:**

Mayor Fincher noted that Mr. Russell Collins was present to review last weeks' findings on the towing regulations. Mayor Fincher apologized for not gathering the information needed and asked Mr. Collins to return next week.




Gary Hostetler informed the Board that property located at 18 Eel River Ave has been sold.
