


- ❖ Code Enforcer Officer Hileman presented her weekly report. Emergency clean up was approved for property located at 915 W. Melbourne Avenue owned by Violet Hunt. Ms. Hileman stated many complaints have been received from neighbors regarding 41 trash bags, dishwasher, and other trash in the back yard. Photos were provided. This report was accepted on a vote of 3-0.
- ❖ Code Enforcer Officer Hileman presented Building Commissioner Hostetler's weekly report. His department has collected \$270.00 in various fees during the past week. A stop work order was issued to Dimas and Norma Saenz, 623 14<sup>th</sup> Street for not obtaining proper permits. Property located at 803 Van Buren Street was declared an unsafe structure due to a fire on February 30<sup>th</sup>. Property is owned by Cathy Leigh. A Certified Notice was sent to Kenneth Fox of 101 W. Miami Ave, on property located at 1804 Woodlawn Ave. This report and recommendations were accepted as presented on a vote of 3-0.
- ❖ The Plan Supervisor's Agreement between The City of Logansport and Dunn & Associates Benefit Administrators, Inc. was approved for signature on a vote of 3-0. This document creates the "City of Logansport Employee Benefit Trust".

- ❖ Fire Chief McMinn's request to promote Rick Bair from Ladderman to Training Officer to replace B.J. Cox, effective February 4, 2006, was granted on a vote of 3-0.
- ❖ An Agreement between The City of Logansport and Logan's Landing Association, Inc. was approved on a vote of 3-0. The terms of the agreement are for 25 years starting February 1, 2006 and ends January 31, 2031, for the sum of \$1.00 per year.
