Board of Public Works and Safety

The Board of Public Works and Safety met for a regular meeting, Thursday, July 20, 2006, at 8:30 a.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent **Roll Call** was taken. Those present were Mayor Fincher, Deputy Mayor Klinck & Joe Casalini. City Attorney Burns was not present.


- ❖ Code Enforcer Officer Hileman presented her weekly report. Thirty nine properties were mowed by the City of Logansport. The following addresses were recommended to the Board of Public Works and Safety for cleanup action: -0-. This report was accepted on a vote of 3-0.
- ❖ Building Commissioner Hostetler presented his weekly report. His department has collected \$240.00 in various fees during the past week. Mr. Hostetler's recommendation that property owned by the Mary Blom Estate be listed as an Unsafe Structure was approved on a vote of 3-0. Property owned by Melissa Harrison, located at 1804 was ordered into Receivership with the owner charged a \$5,000 fine. Action reports were received from Brian Dawnes, Leesburg, IN. for property located at 700 Washington Street and 106 9th Street. There is some concern in regard to the understanding of "several months". Mr. Hostetler will ask for clarification. A meeting is being arranged between Mr. Cruz, Mr. Dave Packard, and Mr. Mike regarding the problem property at 419 E. Market. The entire report was accepted on a vote of 3-0.
- ❖ Shea Young and Lindsey Rozzi presented details and requests for the upcoming fund raiser for Logan's Landing; Taste of Cass County, Saturday, August 12th from 5:00 p.m. to Midnight. It was agreed that the Noise Ordinance would be suspended until Midnight. There will be 2 bands, beer tent and fireworks. Melbourne Avenue will be closed between 4th and 5th Streets from 11:00 a.m. until 1:00 a.m. on Sunday. Spray paint is allowed to ID booth space. All requests were approved on a vote of 3-0.



- ❖ Police Chief Rozzi presented the activities of his department for the month of June.
- ❖ Dumpster request from Rick Calloway, 100 W. Linden Ave. was approved on a vote of 3-0. The purpose of the dumpster is to collect roofing materials from July 24th until August 14th.
