Board of Public Works and Safety

The Board of Public Works and Safety met for a regular meeting, Wednesday, December 26, 2007, at 5:00 p.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent **Roll Call** was taken by Clerk Treasurer Bland. Those present were Mayor Michael Fincher, and Joe Casalini. Others present: Fire Chief McMinn, Dee Hileman, Code Enforcement Officer, Stan Williams, Planning Director, and Building Commissioner Hostetler. Deputy Mayor Klinck and Deputy City Attorney Lisa Traylor-Wolff were absent.

Code Enforcer Officer Hileman delivered her weekly report. Golfview Drive, along Mike Anderson car dealership

Regency Place, Area 5

Woodbridge Avenue, Woodbridge Nursing Home

Tomlinson Drive, a portion between Glenwick Drive and Timber Ridge Road within the City

Grant Street from Seaton to Northern Avenue.


Mr. Williams said the Planning Department will take care of filing the necessary paper work with the State. Mr. Williams will need a copy of the Board of Public Works and Safety Minutes acknowledging these city streets. Joe Casalini moved, second by Mayor Fincher to accept the streets as presented. Motion passed 2-0.

Fire Chief McMinn presented his department's activity report for the month of November. Chief McMinn also submitted the resignation of Rick Bair as Training Captain with the recommendation to the Board of Public Works and Safety to accept the request. The request was granted on a vote of 2-0; effective January 1st, 2008.
