- ❖ Code Enforcer Officer Hileman delivered her weekly report. The following address (es) is/are recommended for Clean up, to the Logansport Street Department for cleanup at a rate of \$250.00 per hour plus a \$50.00 Administration and \$50.00 fine: The recommendation(s) and entire report is accepted on a vote of 3-0.
- ❖ Building Commissioner Hostetler presented his weekly report. His department has collected \$1,005.00 in various fees during the past week. Certified notices were issued to Michael Rehling, 717 Bringhurst; Eldon Turner, 702-704 Bringhurst; and William Thomas, 1437 Meadlawn Ave. Properties located at 1907 North Street and 1327 Michigan Ave, were declared an Unsafe Building as defined under The City of Logansport Ordinance 97-32. His report was accepted as presented on a vote of 3-0.
- ❖ Ms. Sonia Long sent a letter to update the Board of Public Works and Safety on her intended action plan for Timothy Gardens, the old Tipton School, 16<sup>th</sup> and Wright Streets. Ms. Long hopes to

#### **Public Comment:**


