- ❖ Code Enforcer Officer Hileman presented her weekly report. The following address (es) is recommended for Clean up, to the Logansport Street Department for cleanup at a rate of \$250.00 per hour plus a \$50.00 Administration and \$50.00 fine: 511 Shultz Street, John Rush. The recommendation(s) and entire report is accepted on a vote of 3-0.
- ❖ Building Commissioner Hostetler delivered his weekly report. His department has collected \$172.00 in various fees during the past week. His report and recommendations were accepted as presented on a vote of 3-0.
- ❖ The Contract of Management Agreement between Roeing Corp and the City of Logansport was continued, as recommended by the IT Committee, for an amount of \$5,000. This allows the city to buy services at a reduce cost. Services include system engineering support, network administration and hardware maintenance. Motion passed 3-0.
- ❖ A request from Bill Shanks, 327 Hamilton Street, for a curb cut was approved on a vote of 3-0.
- ❖ Steve McIntire and his crew were awarded the Mayor's Cup for serves provided to the city; cleaning an area along Erie Avenue of trash and fallen tree limbs. Mr. McIntire was present to accept the Award on behalf of himself and the crew saying, "It was needed to be done."
- ❖ A dumpster request was granted to Jeff Marshal, Cecil Street, for a 20 yard dumpster to sit at 1010 Michigan Ave. to collect roofing materials. The request was inspected and approved by Street Commissioner Don Crain.
