The Board of Public Works and Safety met for a regular meeting, Tuesday, October 09, 2007, at 5:00 p.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent **Roll Call** was taken by Clerk Treasurer Ellen Bland. Those present were Mayor Fincher, Deputy Mayor Linda Klinck and Joe Casalini. Others present: Code Enforcement Officer Dee Hileman, Fire Chief McMinn, Police Chief Rozzi and Building Commissioner Hostetler. Deputy City Attorney Lisa Traylor-Wolff was present.

- ❖ Code Enforcer Officer Hileman presented her weekly report. The following address (es) is/are recommended for Clean up, to the Logansport Street Department for cleanup at a rate of \$250.00 per hour plus a \$50.00 Administration and \$50.00 fine: -0- The recommendation(s) and entire report is accepted on a vote of 3-0.
- ❖ Building Commissioner Hostetler presented his weekly report. His department has collected \$430.00 in various fees during the past week. A temporary certificate of occupancy was issued to Kentucky Fried Chicken/Long John Silver, located at 3411 E. Market Street. A certificate of occupancy was issued to Cynthia Cox Gentry at 112 Kingsmill Drive and Shawn W. Nubel at 104 Kingsmill Drive. The entire report and recommendations was accepted on a vote of 3-0.
- ❖ Police Chief Rozzi delivered the activity report for the month of September for the Logansport Police Department.
- ❖ Brian Shafer, Executive Director of Logansport Cass County Chamber of Commerce, received permission to use a sidewalk mannequin during community events, local and regional sports events and contributing Chamber member messages. The necessary liability insurance information is on file in the Mayor's Office. Permission from the Planning Commission is also necessary.
- ❖ Shae Young, Logan's Landing Executive Director, received permission to use a 75 pound sign to place in front of new businesses, businesses who have improved their appearance, and for special Logan's Landing events. Ms. Young also received permission for a Scarecrow Row contest allowing businesses to decorate a scarecrow and attach it to a light pole that will be designated by Logan's Landing. The scarecrows will be placed on the


sidewalk, but will be placed in a manner that will not hinder pedestrian traffic or restrict vision of vehicular traffic. The necessary liability insurance information is attached to these Minutes. Permission from the Planning Commission is also necessary.


- ❖ Cass County Veterans Organization, under the direction of Jeff Mercier, received permission to use city streets on November 12th for the annual Veterans Day parade. The route is the same as in years' past. A map was provided. Mr. Mercier also received permission to use city streets on December 7th, at 1:00 p.m. for the purpose of a short program in remembrance of Pearl Harbor. A map was provided of said location.
- ❖ A dumpster request was approved for Richard Hipsher, 1822 High Street for the purpose of collecting roof materials. The area was examined and approved by Street Commissioner Don Crain.
- ❖ **Margret Rittenhouse** was awarded the Mayor's Cup for her long term devotion to collecting recyclables at the Senior Housing Center. She has truly presented a great service to her community.
