The Board of Public Works and Safety met for a regular meeting, Wednesday, July 30, 2008, at 5:00 p.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent **Roll Call** was taken by Clerk Treasurer Bland. Those present were Mayor Fincher, Deputy Mayor Klinck, and Joe Casalini. Others present: Building Commissioner Hostetler, Jan Fawley, Park Administrator, and Fire Chief McMinn. Deputy City Attorney Lisa Traylor-Wolff was present.

Minutes from July 23, 2008 accepted as presented on a vote of 3-0.

Claims of \$187,426.71; approved as presented.

Approval Electrician License: John Sorg, Ft. Wayne; and Randy Michael, Logansport.

Addition to Agenda: State Community Development Block Grant Agreement.

New Business:

There was no Code Enforcement Report.

Building Commissioner Hostetler delivered his weekly report. The department has collected \$1,095.00 in various fees during the past week. A certificate of occupancy was issued to O'Reilly Auto Parts, 2525 E. Market Street. Property located at 625 Park Ave, owned by Ron Sink Jr.; due to a fire on July 25th the structure is determined to be unsafe and dangerous. The recommendation(s) and entire report is accepted on a vote of 3-0.

Logan's Landing requested:

- 1) Street closures; Melbourne Ave from 3rd to 5th Street beginning at 8:00 a.m., Saturday, August 9th through 10:00 a.m., Monday, August 11th.
- 2) Suspend curfew and noise Ordinance from 9:00 p.m., August 9th until 2:00 a.m. August 10th.
- 3) Allow fireworks show at 10:00 p.m.
- 4) Allow Old Style Inn's Beer Tent, which will be set up on the south side of the Depot at 4th and Melbourne Ave.

Jan Fawley, Park Administrator, presented a proposed traffic plan for the Tower Park Triathlon for Kids to be held Saturday, August 2nd from 8:00 a.m. to about 9:00 a.m. Special officers led by Dale Turnpaugh will direct traffic for the event. The request is to supervise and direct vehicular traffic on 19th, 21st, and Wright Streets. An aerial map was provided. Permission was granted on a vote of 3-0.

Tim Rich, Harris Glass; asked for permission to block of Pearl Street between Market and Broadway to replace glass on the second floor of Salin Bank. They will need half a


day; from 8:00 a.m. until 12:00 noon, on Monday, August 4th. The main purpose of the request is safety for the pedestrians. Request was granted on a vote of 3-0.

CDBG Grant Agreement was presented for signatures. Deputy Mayor Klinck pointed out that this matter has been approved previously. There was no discussion.
