Code Enforcer Officer Hileman presented her department's weekly report. Mayor Fincher delivered Building Commissioner Hostetler's weekly report. The department has collected \$35.00 in various fees during the past week. Via a letter; Todd Zeiger, Historic Landmarks Foundation of Indiana, requested and was granted permission for closure of the 10 ft. alley running north/south directly east of 315 E. The purpose of the closure is for a major construction project on 315 E. Market Street. The work will commence on March 9, 2009. The request is for a maximum of 120 days ending in July. 

Fire Chief McMinn presented the activity report for his department for the month of February.


