The Board of Public Works and Safety met for a regular meeting, Tuesday, November 10, 2009, at 8:30 a.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.


Fire Chief McMinn presented the month of October's activity report for the Fire Department.
