Board of Public Works and Safety

The Board of Public Works and Safety met for a regular meeting, Wednesday, December 7, 2011, at 5:00 p.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent Roll Call: Those present were Mayor Fincher, Linda Klinck and Joe Casalini. Others present: Code Enforcement Officer Dee Hileman, and Building Commissioner Hostetler. Deputy City Attorney Mark Leeman was present.

Public: Chamber Director Brian Shafer, Attorney Matt Barrett, and James Quigney.

Minutes from November 30, 2011, accepted as presented on a vote of 3-0.

Claims of \$700,394.96 approved as presented.

New Business:

Code Enforcer Officer Hileman presented her department's weekly report. The following address (es) is (are) recommended for the Logansport Street Department for cleanup at a rate of \$250.00 per hour, \$75.00 landfill fee, plus a \$50.00 Administration and \$50.00 fine: Ali Murray, 2311 Spear Street, Jose Zendejas & Ms. Gonzales; 122 W. Linden Ave. Emergency clean up action on properties located at 128,130,200, and 202 E. Miami Ave; owned by Michael Hosmer. Action for James and Julia Quigney, 1728 Michigan Ave was extended for one week as Mr. Quigney appeared before the Board. The finding of facts and entire report were affirmed on a vote of 3-0.

Building Commissioner Hostetler delivered his weekly report. The department has collected \$890.00 in various fees during the past week. Mr. Hostetler will receive pre-demolition asbestos removal bids on the Maiben building, 216 N. Cicott Street; by December 21, 2011. Dumpster request was re-issued to Lynnea Strong, 1119 E. Broadway from December 17 until December 31, 2011. The finding of facts and entire report affirmed on a vote of 3-0.

Memorandum from INDOT to the City of Logansport explains State Road 25 relinquishment and rerouting of SR 25 within the city limits. INDOT will relinquish SR from western town limit to the intersection of 6th Street and High Street. INDOT will take on portions for the relocated SR 25. In consideration of the relinquishment INDOT proposes to provide funds made available over a three to five year period in the amount of \$3,500,000. Funds would become available in the year that the Hoosier Heartland opens to traffic; anticipate that the funds would become available in 2014. The Agreement of the proposal is non-binding but will be used in the preparation of Memorandum of Agreement for the relinquishment. City Attorney-elect Matt Barrett, on behalf of Mayor-elect Ted Franklin, requested a thirty day delay in signing this document. Mayor Fincher called for vote, second by Linda Klinck. Motion to sign agreement passed 3-0.

The Eastgate Deed of Dedication between the City of Logansport and Michael and Amii McCord was approved on a vote of 3-0. City Attorney Mark Leeman explained that this action will clarify an on-going problem of ownership involving a sliver of land.

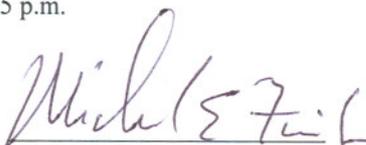
