The Board of Public Works and Safety met for a regular meeting, Wednesday, November 16, 2011, at 9:00 a.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent Roll Call: Those present were Mayor Fincher, Linda Klinck and Joe Casalini. Others present: Code Enforcement Officer Dee Hileman, Fire Chief Mittica, Street Commissioner Don Crain and Building Commissioner Hostetler. Deputy City Attorney Mark Leeman was present.

Minutes from November 09, 2011, accepted as presented on a vote of 3-0.

Claims of \$170,635.76 approved as presented.

Old Business: Bids for supplies for various departments awarded to Mann Concrete as primary/Merrill Louthain as secondary; Engineer Aggregates and Central Paving, on a vote of 3-0.

New Business:

Code Enforcer Officer Hileman presented her department's weekly report. The following address (es) is (are) recommended for the Logansport Street Department for cleanup at a rate of \$250.00 per hour, \$75.00 landfill fee, plus a \$50.00 Administration and \$50.00 fine: -0-. The finding of facts and entire report were affirmed on a vote of 3-0.

Building Commissioner Hostetler delivered his weekly report. The department has collected \$180.00 in various fees during the past week. Joe Dunn at 922 E. Broadway has submitted an action plan for this property. Mr. Hostetler will stay aware and report on the progress. A report from Mattox & Associates on property located at 216 N. Cicott indicates the structure is not good. Also, due to the nature of the business formally located in this building, it is very likely that there are hazardous materials that should be removed before demolition. Mayor Fincher moved seconded by Joe Casalini to temporarily close the east and west end of the alley, between Cicott and Barron Streets; leaving room for residence to get in and out. The finding of facts and entire report affirmed on a vote of 3-0.

Fire Chief Bernie Mittica presented the police department's activity report for the month of October. INDOT and the City of Logansport entered into contract identified as EDS# A249-12-320474, Des. No.: 1172434; on a vote of 3-0. This project is for intersection improvement, roundabout, for the intersection improvement 18th Street at Main Street roundabout, in the City of Logansport.
