The Board of Public Works and Safety met for a regular meeting, Wednesday, September 21, 2011, at 9:00 a.m., in the City Chambers, 3rd floor, City Building, Logansport, Indiana.

Silent Roll Call: Those present were Mayor Fincher, Linda Klinck and Joe Casalini. Others present: Code Enforcement Officer Dee Hileman, Police Chief Rozzi, and Building Commissioner Hostetler. Deputy City Attorney Mark Leeman was present.

Minutes from September 14, 2011, accepted as presented on a vote of 3-0.

Old Business: Demolition bids were awarded to Apex Construction for property located at 115 E. Linden, 315-317 Cliff Dr, and 1425 Erie Ave. Alulbach Construction was low bid on property located at 1907 North Street and was awarded that bid.

New Business:

Code Enforcer Officer Hileman presented her department's weekly report. The following address (es) is (are) recommended for the Logansport Street Department for cleanup at a rate of \$250.00 per hour, \$75.00 landfill fee, plus a \$50.00 Administration and \$50.00 fine: John Centers, 1513 Spear Street. Sixty nine addresses were placed on the Continuous Order under Ordinance 2009-08. The finding of facts and entire report were affirmed on a vote of 3-0.

Building Commissioner Hostetler delivered his weekly report. The department has collected \$1,995.00 in various fees during the past week. City Attorney Mark Leeman is gathering information to file contempt charges against owners of property located behind 212 6th Street, 216 N. Cicott and Tipton school. The finding of facts and entire report affirmed on a vote of 3-0.

Police Chief A.J. Rozzi submitted notice on the retirement of Wesley K. Peters, effective the close of business on the 16th of September 2011. "Wes served the City of Logansport as an officer for 22 years six months, he will be missed."


