City Clerk Treasurer, Request to hold Annual City Surplus Auction, was granted on a motion by Mayor Franklin, seconded by Chris Armstrong and carried on a vote of 3-0. • REPORTS


- ❖ **Acting Building Commissioner, Deb O'Connor appeared**, presenting her report. Five property owners were ordered to appear; however, two permits have been issued since the order, one is currently working on property, another owner did not appear and the property at 421 Day Street, which is in very bad condition, is owned by the bank. Ten permits were issued and three contractor registrations were mailed. Mayor Franklin made a motion to accept Ms. O'Connor's report as presented. Ron Miller seconded the motion. Motion carried 3-0.
- ❖ **Code Enforcement Officer's Report-George Franklin** presented his written report. Six trash violations with letters and door notices issued. One vehicle was tagged. Thirty Five notices went to property owners regarding weeds and mowing. Mayor Franklin made a motion to accept the report as presented. Chris Armstrong seconded the motion. Motion carried 3-0.
- ❖ **Superintendent of Public Works –Dan Williams**, presented his written reports for the Street and Cemetery Department. Still, once again, Williams was congratulated on the fine job he has been doing and the attention paid to the city streets before the out of town dignitaries arrived. Ron Miller made a motion to accept the report as presented. Chris Armstrong seconded the motion. Motion carried 3-0.
- ❖ **Police Chief, Mike Clark**—appeared before the board announcing the Annual Bike Rodeo on June 9th had been quite a success. One Hundred twenty-eight youngsters attended. Twelve new bicycles were given away. Eight to ten Wal-Mart employees volunteered to help that day. Ron Miller made a motion to accept the report. Chris Armstrong seconded the motion. Motion carried 3-0.
- ❖ **Fire Chief, Mark Strong**—presented his monthly report which also included his mileage report. Discussion followed. Ron Miller made a motion to accept the report. Mayor Franklin seconded the motion. Motion carried 3-0.
