NEW BUSINESS:

- **Chris Armstrong—Roadblock request**—Chris requested moving the monthly roadblocks due to a complaint. She would like to move the Friday roadblock down to the light at 3rd Street, still remaining on Broadway, and keep Saturday's roadblocks at the 6th Street light. She did not request this be a permanent solution. She felt this could be a trial period till the end of roadblock season. Ron Miller made a motion that the relocation as presented be approved. Mayor Franklin seconded the motion. Motion carried 3-0.

She also wanted to borrow 15 orange cones to display signs. Ron Miller made a motion to approve the request. Chris Armstrong seconded the motion. The motion carried 3-0.


- **REPORTS**

- ❖ **Acting Building Commissioner, Deb O'Connor not present due to vacation time.**
- ❖ **Code Enforcement Officer's Report --** Report presented which contained four trash violations, two continued violations and ten Weed and Mowing Notices were sent. Per the report 407 Weed and Mowing notices to date, with 132 yards mowed, 55 cleared with a \$50 fine and 7 cleared with a \$100 fine. Ron Miller made a motion to accept the report. Mayor Franklin seconded the motion. Motion carried 3-0.
- ❖ **Superintendent of Public Works –Dan Williams,** presented his written reports for the Cemetery and Street Department. Discussion followed. When asked about the mowing, Williams replied "it was non existent". Ron Miller made a motion to accept the reports. Chris Armstrong seconded the motion. Motion carried 3-0.
- ❖ **Police Chief, Mike Clark—**present indicating he had no written report. "Things were going well in his Department". Ron Miller made a motion that the verbal report be approved. Mayor Franklin seconded the motion. Motion carried 3-0.
- ❖ **Fire Chief, Mark Strong—**present, reported due to the high temperature, they have received several EMT calls. Chief Strong cautioned everyone to drink plenty of water, be extra careful on burning and wisely shoot off fireworks. Mayor Franklin asked Strong to inspect the site where the fireworks will be displayed. Mayor Franklin made a motion to accept the Chief's verbal report. Ron Miller seconded the motion. The motion carried 3-0.
