Minutes were approved on a motion by Ron Miller, seconded by Chris Armstrong. Motion carried 2-0.

**APPROVAL OF CLAIMS: \$216,096.31**

Ron Miller made a motion that the claims in the amount of \$216,096.31 be approved. Chris Armstrong seconded the motion. Motion carried 2-0.

**APPROVAL OF LICENSES:**

Electrician License for Bryan Cass d/b/a Bryan Cass Electric, LLC, was approved on a motion by Ron Miller, seconded by Chris Armstrong. Motion carried 2-0.

**OLD BUSINESS:**

**Alfonzo Perez 516 W. Broadway** Chris Armstrong, Community Development Director, reported this situation had been turned over to the Zoning Office.

**Scott Kloenne 1527 George Street** Mr. Kloenne was present. Kloenne reported he had done some work on the property, but probably not enough for the satisfaction of the Code Enforcement Officer. Kloenne indicated he only had one day of the week to work on the cleanup, but would continue to get the work done. Armstrong recommended he be given until September 25<sup>th</sup> to complete the work. Kloenne agreed. On a Motion by Ron Miller and seconded by Chris Armstrong, it was voted 2-0 to extend Kloenne's timeline until September 25<sup>th</sup>.

**BUILDING COMMISSIONER:** **Bill Drinkwine** presented his written report for review, stating he is moving forward on the properties at 208 S 6<sup>th</sup> Street and 210 S 6<sup>th</sup> Street with demolition . Ron Miller made a motion to accept the report. Chris Armstrong seconded the motion. Motion carried 2-0.

**CODE ENFORCEMENT OFFICER:** **George Franklin on vacation.**

**SUPERINTENDENT OF PUBLIC WORKS:** **Dan Williams**, present. Williams submitted his written report, stating his department has been very busy, trying to get caught up on the limbs and brush routes. Armstrong commended Williams on the fine job that he is doing. Williams then spoke of the "cleanups" the Street Departments has done. In 2013, bills and liens of \$20,000 have been filed and his department has received to date \$250, remarking it takes little knowledge to learn the Street Department is losing revenue. In 2012, the Street Department had \$11,000 out and received \$150 back, stating the amount of cleanups has almost doubled, also stating the cleanups take a considerable amount of time from his department. Ron Miller made a motion to approve the report. Chris Armstrong seconded the motion. Motion carried 2-0.


**POLICE CHIEF:** **Mike Clark, Police Chief**, present.

**FIRE CHIEF:** **Mark Strong, Fire Chief**, not present.


