School Resource Officer Agreement Mike Clark Police Chief...We currently do not have a Resource Officer in Lincoln Middle School. The school corporation had expressed an interest in having

one. We have one in Columbia Middle School as well as Logansport High School. We received a Cops grant through the Department of Justice to partially fund this over a four year period and the agreement is between the Police Department, the City and the School Corporation. The School Corporation will partially fund the SRO full time position in the amount of \$30,000 per calendar year. Mayor Franklin made a motion to approve the request. Ron Miller seconded the motion. Motion carried 3-0.




PARKS ADMINISTRATOR: Rich Brewer not in attendance
