BUILDING COMMISSIONER: Bill Drinkwine presented his written report.

Drinkwine asked that the determination of this property be delayed, as Harmon is in the process of registering all of his rentals. After the properties are registered, he will do an inspection. At that time, the property will be addressed. Ron Miller made a motion that the Building Commissioner's report be approved as presented. Chris Armstrong seconded the motion. Motion carried 3-0. Mayor Franklin went on to commend Bill's accomplishments for the City.


POLICE CHIEF: Mike Clark not present, excused by the Mayor.
