After receiving approval from the Chief of Police, Planning Coordinator, Parks Administrator and the Fire Chief, requests must be turned in to the Street Department located at 612 Race Street. Upon Street Commissioner approval, the Street Department will forward the request to the Board of Works. Requests must be submitted to the Street Department with all other department approvals by 8am on the Monday prior to the Board of Works meeting on Wednesday. Please be sure to give yourself enough time to get approval for your event.
- The Board of Works meets each Wednesday at 3:00 PM in the City Council Chambers on the 3<sup>rd</sup> floor of the City Building, 601 East Broadway, Logansport, IN.
- If your closure includes a State Highway, you must notify the Mayor's Office prior to turning in your request.
- It is wise to come to the meeting the day your request is up for approval in case the Board has additional questions so it is not delayed.
